

Investment Objective

The World Stars Global Equity Fund seeks to achieve its objective by investing in a concentrated selection of shares in leading global companies with enduring competitive advantages and a long runway of growth.

We select companies based on our own fundamental research, taking a long-term horizon. We do not follow benchmarks and always seek to invest in quality and value.

Quality means companies that are global leaders, have strong competitive positions and pricing power in structurally attractive and growing markets, have management teams with strong records of value creation and have robust balance sheets.

Value means buying those companies at prices that allow for the prospect of significant capital growth over 5-10 years or more.

Portfolio Comment

In an eventful year, our companies continued to make good progress, delivering market share gains and robust underlying growth in profits and cash flow. On a weighted average basis in USD we estimate that the portfolio has achieved 13% revenue and 14% earnings growth in CY2025 overall.

Macro news flow in December was focused in the US with a 25 bps cut in rates, core CPI of 2.6% below expectations despite the impact of tariffs, and 4.3% growth in Q3 GDP driven by consumer spending and a 9% rise in exports. The Fed raised its forecast for 2026 GDP to 2.3% but signalled caution on further monetary easing.

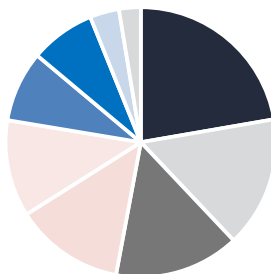
Salesforce (+15%) reported strong Q3 results and raised its full year guidance on revenues and cash flow. Its AI-related products of Data 360 and AI Agentforce more than doubled revenues in the quarter.

Walt Disney (+10%) was boosted by the auction for Warner Bros Discovery, which has emphasized the enduring value of high-quality content. This transaction will result in market consolidation and increased pricing power in the industry. Disney's streaming prices are already below Netflix before taking account of these developments.

Roche (+7%) announced another positive Phase 3 readout for Giredrestrant (breast cancer, oral), a drug which we estimate could generate revenues of CHF3-4bn in 2029, compared to FY2025E group revenues of CHF61bn.

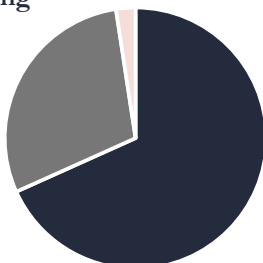
GICS Sector Allocation

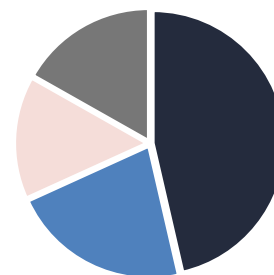
Geographic Exposure by Listing

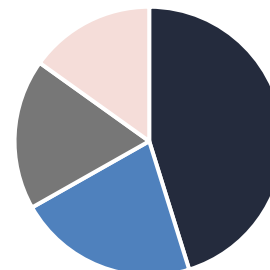
