OBJECTIVES AND INVESTMENT POLICY

Investment Objective

The objective of the sub-fund is to achieve capital growth over the long term. For these purposes, long term means 5 to 10 years.

Investment Policy

The sub-fund seeks to achieve the objective by investing in a concentrated basket of equities in leading global companies, which are selected based upon the Investment Manager's fundamental research, taking a long-term horizon and always seeking to invest in quality and value.

The investments of the sub-fund will principally be a concentrated section of shares in global companies.

The remaining assets will be held in cash, cash equivalent investments and in government and investment grade bonds.

It is envisaged that the companies will be predominantly based and listed in developed markets. However the sub-fund may invest up to 15% in shares of companies based and listed in emerging markets.

Benchmark

The sub-fund is managed actively with no reference to any benchmark.

Fund Currency

The reference currency of the sub-fund is the USD.

Distribution Policy

Income generated is reinvested.

Subscription and Redemption

Investors may purchase or sell shares of the sub-fund on a daily basis (Luxembourg & London business days).

Risk Disclaimer

The risk and reward indicator illustrates where the sub-fund is positioned in terms of its possible risk and reward. Why is this Sub-Fund in this category?

The sub-fund is subject to a high level of risk being linked to typical risks of equity markets, such as macro-economic trends. At this time, the level of risk and reward profile is equal to 6.

Not all risks affecting the sub-fund are adequately captured by the synthetic risk indicator. The following risks may affect the sub-fund:

Operational risk - That may occur due to technical issues for example natural disasters and fraud.

Currency risk - When the sub-fund invests in assets denominated in a different currency. A devaluation of the asset's currency relative to the currency of the sub-fund will lead to a reduction in the value of the sub-fund. The charges investors pay are used to cover the cost of running the fund, including the cost of marketing and distributing it. These charges reduce the potential growth of your investment.


The ongoing charges may vary from year to year and include investment management (if applicable), management, administration and depositary fees. They do not include portfolio transaction costs and performance fees.
