

Investment Objective

The World Stars Global Equity Fund seeks to achieve its objective by investing in a concentrated selection of shares in leading global companies with enduring competitive advantages and a long runway of growth.

We select companies based on our own fundamental research, taking a long-term horizon. We do not follow benchmarks and always seek to invest in quality and value.

Quality means companies that are global leaders, have strong competitive positions and pricing power in structurally attractive and growing markets, have management teams with strong records of value creation and have robust balance sheets.

Value means buying those companies at prices that allow for the prospect of significant capital growth over 5-10 years or more.

Portfolio Comment

Our World Stars Global Equity fund continued to perform strongly in September. Performance was led by our consumer companies which accounted for four of the top ten. Valuations of these stocks have started to recover from multi-year lows driven by a view that pressures on consumers will ease significantly over the next 12-18 months and that long-term secular drivers remain intact.

It was a significant month for macro news flow. Headline CPI fell to close to 2% in Europe and the US, albeit with continuing pressures in services and shelter respectively. The US Fed cut rates by 50bps, its first reduction since March 2020, and the ECB cut by a further 25bps. In China, the PBoC announced a material stimulus package designed to support growth and deliver a modest rise in prices. CPI in China has averaged below 0.5% since Q2 2023.

Meta (+10%) was again the top performer. The business has multiple growth levers, exemplified by the recent renewal of the partnership with EssilorLuxottica for their Ray-Ban Meta smart glasses.

Stocks with a significant exposure to China received a material boost from the stimulus announcement, notably LVMH which rose 19% on the news. Otis (+10%) should benefit from a potential stabilization of the local property market. China is the third largest global market by sales for Pernod Ricard (+5%), and Diageo (+5%) also has a strong position in China across its portfolio of imported and local premium spirits.

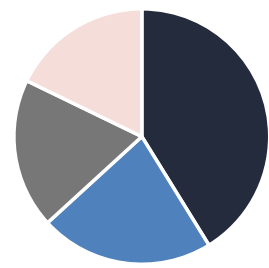

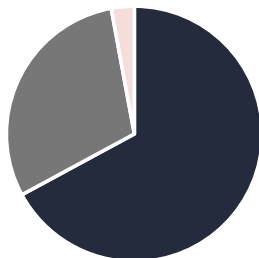

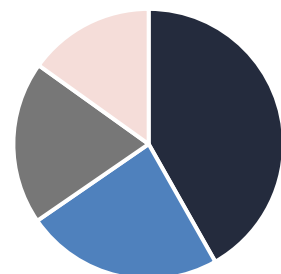
Geographic Exposure by Listing
