

Investment Objective

The World Stars Global Equity Fund seeks to achieve its objective by investing in a concentrated selection of shares in leading global companies with enduring competitive advantages and a long runway of growth.

We select companies based on our own fundamental research, taking a long-term horizon. We do not follow benchmarks and always seek to invest in quality and value.

Quality means companies that are global leaders, have strong competitive positions and pricing power in structurally attractive and growing markets, have management teams with strong records of value creation and have robust balance sheets.

Value means buying those companies at prices that allow for the prospect of significant capital growth over 5-10 years or more.

Portfolio Comment

After strong gains this year our World Stars Global Equity fund consolidated in October, in line with the global equity market. The month was characterised by an increase in geopolitical tensions in the Middle East, uncertainty over the US election and concerns over the efficacy of the stimulus measures in China. The US dollar currency index rose by 3% and the yield on 10 years Treasuries increased by 50 bps to 4.3%.

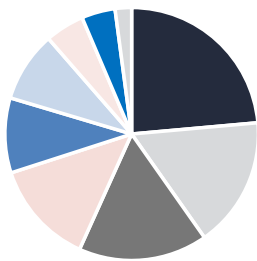
In our portfolio, 21 of our investee companies have reported Q3 earnings with a broad picture of robust revenue growth, improving margins and a reiteration of full year earnings guidance.

Digital stocks accounted for five of the top ten performers. Strong revenue growth and margin expansion was a feature of our digital platforms. *Meta* (-1%) reported 20% revenue growth and an increased EBIT margin of 43%. *Amazon's* Q3 EBIT margin rose from 8% to 11% boosted by AWS and international e-commerce. *Alphabet's* (+3%) cloud revenues grew by an exceptional 35% with margins of 17%. In each case these businesses are extracting significant gains from operating leverage, tight cost control and from investment in AI, which is delivering increased appeal to users of the platform and to advertisers.

*Amphenol* (+3%) led our industrial holdings with 15% organic growth in revenues in Q3 and a 110bps rise in the EBIT margin to 22%. In the IT & Datacom division revenues rose 59% year-on-year with strong demand for AI-related applications.

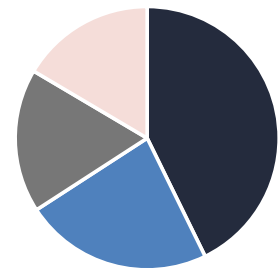
GICS Sector Allocation

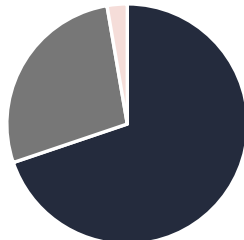

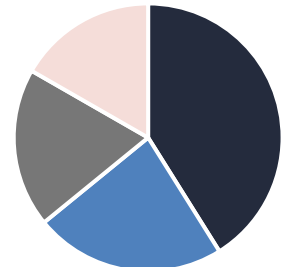
Geographic Exposure by Listing
